#### 1. INTRODUCTION

CopyBet respects and honors the confidentiality of internet visitors and users of its products and services. When processing the personal data you've provided, CopyBet acts in accordance with changes introduced to the General Data Protection Regulation (GDPR) that came into effect in the European Union on May 25th, 2018. CopyBet also actively tracks any possible changes in the United Kingdom General Data Protection Regulation (UK-GDPR) after Brexit, which took place on January 31st, 2020. The British Parliament is currently creating a new law; however, CopyBet's activities cover both GDPR and UK-GDPR in order to provide its users with confidentiality compliance of the highest possible level.

Any information about your activities collected by our staff is used for business purposes only. Usage of this data is intended for improvement of the service level, assessment of your financial abilities and needs, as well as due notification of new services and products offered by CopyBet.

If we are legally obligated to provide your personal data to other organizations, such as the government, we do it securely and do not provide more information than the situation requires. These rules are applied to existing, as well as past and prospective clients.

#### 2. PERSONAL INFORMATION

Personal data is any information associated with a living person (a personal data subject), which may be directly or indirectly used (combined with other information) for personal identification.

We collect your personal data only in accordance with regulations and the law. We can collect it from different sources. It may be relevant to any of our products or services that you are currently using or used in the past. We can also collect your data when you communicate with us, for example, visit our websites of mobile channels, contacts us over the phone, or ask the company's representatives about any products and services CopyBet has to offer. Some part of this data comes directly from you when you register and provide identification documents. We can also get some data from publicly available sources.

The data we collect may include:

The information you provide, for example:

- personal information, such as name, sex, date and place of birth;
- contact information, such as a postal address, e-mail address, phone number;
- information about your identity, such as identity card with photo, passport data, nationality;
- logins and passwords or user subscription data, such as Profile login credentials;
- any other personal information that you provide by completing forms or communicating with us, whether by the phone, e-mail, Internet, or any other method.
- The information we collect or generate, for example:
- your financial information and information about your cooperation with us, including products and services you use, as well as the history of your deposits/withdrawals and transactions;
- information about transactions you make with CopyBet affiliates;
- information about your gadget/PC/portable device and software, such as IP address;
- cookies and other similar technologies;



• internal analytics data, such as marketing analytics, sanction and money-laundering checks. Information about received warnings, notifications, news, and subscriptions. We use your data only given your consent or if we have some other legal reason to use it.

#### 3. COOKIES

Cookies are information files used by websites for counting visitors (traffic measurement). This information from the website server is temporarily kept on your hard drive or your mobile device when you visit the website the first time. Cookies make it possible to recognize your browser when you visit the website again.

Cookies usually store anonymous data such as unique identification code which is randomly generated. They store your preferred language and the country you came from. All the information collected is confidential and not linked to any certain client directly.

CopyBet uses cookies in order to determine how much you are interested in services and to access our visitors' activity. Cookies are also used for determining the most successful marketing materials and checking out Internet resources for referring potential clients.

By using our website you agree to accept cookies. All Internet browsers allow changing cookie parameters. You can turn cookies off or block them; however, some of them are necessary to use our website properly.

#### 4. SAFETY TECHNOLOGIES

CopyBet uses a modern security Secure Sockets Layer technology (SSL). This technology allows establishing an encrypted link between a web server and a browser and guarantees the safety of your information. SSL technology safely protects information from being captured by third parties. We constantly improve our safety technologies to protect the system from unauthorized access and to make it impossible to use our database without permission.

#### 5. SHARING INFORMATION WITH THIRD PARTIES

According to the rules stated in the Safety Policy, third parties by no means can obtain information about our clients. This information is accessible by CopyBet's business partners only in order to improve the quality of service and to inform our clients about our new services in a timely manner. Companies that somehow provide high-quality services to CopyBet's clients but aren't our partners, can access only a minimum portion of information about our clients to carry their business.

Any personal information can only be shared at your request or with your permission. The exception to the above is when your personal data is shared with regulatory or law enforcement authorities.

Please note that CopyBet values its reputation too much and thus can't afford to share your confidential information with any other party.



## 6. SHARING INFORMATION WITH REGULATION AND LAW ENFORCEMENT AUTHORITIES

On extraordinary occasions, CopyBet can disclose a client's personal information to third parties if such disclosure is necessary according to applicable law and other regulations. For instance, we will be obliged to disclose the personal information of a client to comply with judicial decisions and official requests. Also, such disclosure will be done in case we need to protect our rights and property.

#### 7. DEFAULT IN PROVIDING INFORMATION

You have the right to refuse to give us information, which is requested by CopyBet staff. However, in this case, we won't be able to give you full support and guarantee high-quality service on your CopyBet Profile.

#### 8. HOW TO UNSUBSCRIBE FROM RECEIVING MAILERS

You can unsubscribe from marketing mailers from CopyBet by following the instructions contained in them. However, you can not unsubscribe from receiving service mailer on payments and information about actual services of CopyBet. It is impossible to unsubscribe from them. You can also send to CopyBet email requests related to advertising materials and your right to share such materials with third parties for marketing purposes.
