Introduction

The website is managed by CopyBet (EU) Ltd. We are a limited company registered in Cyprus under registration number HE387170 and we have our registered office at 22A Agias Zonis, Floor 1, Flat/Office 101, Limassol, 3027, Cyprus.

CopyBet (EU) Ltd, and its affiliates, subsidiaries and related entities including CopyBet UK Ltd ("CopyBet", "us", "we", "our") are committed to protecting the privacy and security of the Personal Data we collect about end customers and users of our services ("you/your").

Unless we notify you otherwise, we are the controller of the Personal Data (defined below in the 'What is Personal Data' section) we process about you. This means that we decide what Personal Data to collect and how to process it.

The purpose of this privacy notice is to explain what Personal Data we collect about you and how we process it when you visit this website and our mobile, tablet and other applications (our "Website"). This privacy notice also explains your rights, so please read it carefully. If you have any questions, you can contact us using the information provided below under the 'Contact us' section.

Who this privacy notice applies to

This privacy notice applies to you if:

1. You visit our Website
2. You enquire about our products and/or services
2. You sign up for our products, services, and/or our betting platform
3. You are an existing customer
4. You contact us by email, telephone or by using our online contact form
5. You sign up to receive newsletters and/or other promotional communications from us

What is Personal Data

'Personal Data' means any information from which someone can be identified either directly or indirectly. For example, you can be identified by an identifier such as your name or an online identifier,.

'Special Category Personal Data' is more sensitive Personal Data and includes information revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, genetic data, biometric data for the purposes of uniquely identifying someone, data concerning physical or mental health or data concerning someone's sex life or sexual orientation.

Personal Data we collect

The type of Personal Data we collect about you will depend on our relationship with you.

We collect and process the following categories of Personal Data about you:

Registration Information	Information we require you to provide us when you register an account with CopyBet such as your name, date of birth, place of birth, sex, postal address, email address, contact number, security information, marketing preferences and any other information we may request from you as part of the registration process.

Verification & Know Your Customer Documentation	Information to enable us to verify your identity. We may request that you provide documents such as a copy of your driver's licence or passport, documentation that confirms your address such as bank statements or utility bills, or any other information we deem necessary to confirm your age and/or identity.
Publicly Available Information	Information from publicly available sources such as social media platforms.
Account Information	Information required or which we may request from you for the continued use of our Website, platforms, products and/or services, including your preference to place a free bet with us when you opt-in via the 'Free Bet' toggle in your account settings.
Cookie & Tracking Information	For information about our use of cookies and similar technology, please see our Cookie Policy .
Platform Activity	Information on how you use our Website such as pages visited and engaged with, content viewed, links and buttons clicked.
Betting & Transaction Information	Your betting, gaming, deposits, Payment Information (see below) and other account transactions.
Correspondence	Your telephone, postal, email, website, and/or other communications with us including through chat and message functions on our Website or through social media channels.
Device Information	Information related to the browser or device you use to access our Website.
Server Logs & Traffic Information	Information collected during your visits to our Website and your Internet Protocol (IP) address, login data, browser type and version, device type, time zone setting, browser plug-in types and versions, operating system and platform.
Payment Information	Information such as your credit/debit card details, bank account details, transaction, deposit and withdrawal history and other data necessary for processing payments and fraud prevention, including security code numbers and other related billing information.

How we collect your Personal Data

We collect most of the Personal Data directly from you by telephone, text or email and/or via our Website.

However, we may also collect your Personal Data from third parties such as:

- reputable companies who provide lead generation contact lists;
- others to whom you have provided consent;
- other betting partners;
- publicly available sources such as social media platforms;
- sub-contractors in technical, payment and delivery services;
- advertising networks;
- analytics providers; and
- search information providers.

We use cookies on our Website.

This helps us to provide you with a good experience when you browse our Website, allows us to improve our Website, and understand how you interact with us.

Sharing your data

As we are part of the CopyBet Group, we may share your Personal Data with, or receive your Personal Data from other companies within our group, such as CopyBet UK Limited, and also disclose your information to third parties in connection with the purposes set out in this privacy notice. These third parties may include:

- business partners, suppliers and sub-contractors who may process information on our behalf for the purposes set out above (Neteller, Skrill, Ecommpay, Apple, Google for example)
- advertisers, social media platforms, and advertising networks
- analytics and search engine providers
- IT service providers

We may also share Personal Data from customers in the European Union (“EU”) with our KYC (Know Your Customer) checking provider, Sumsb, and with our marketing and emailing platform, GetResponse.

This Website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy statements. When you leave our site, we encourage you to read the privacy policy of every website you visit.

Where we are under a legal or regulatory duty to do so, we may disclose your details to the police, regulatory bodies or legal advisors, and/or, where we consider necessary to protect the rights, property or safety of CopyBet, its personnel, users or others.

International Transfers

We process your Personal Data within the European Economic Area (“EEA”) and the United Kingdom (“UK”). Where we transfer your Personal Data to the UK, we rely on the decision of the European Commission, which has confirmed the UK provides an adequate level of protection for personal data (an “adequacy decision”). You can [view this adequacy decision here](#).

It is unlikely that we will ever share your Personal Data outside the EEA or UK. However, if it becomes necessary for the purposes of providing our services to you, we will only share it with organisations in countries benefiting from an adequacy decision or where we have taken appropriate steps to ensure that the Personal Data processed has an essentially equivalent level of protection to that guaranteed in the EU. We do this by ensuring that:

- Your Personal Data is only processed in a country subject to an adequacy decision from the European Commission; or
- We enter into Standard Contractual Clauses (“SCCs”) with the receiving organisations and adopt supplementary measures, where necessary. (A model form of the SCCs can be found here [Standard Contractual Clauses \(SCCs\)](#)).

We will inform you about any such transfer of your Personal Data by updating this privacy notice, by reference to (i) the categories of Personal Data transferred, (ii) the territory to which they are transferred; and (iii) the mechanism used to safeguard any such transfer.

How long we keep your data

We will retain your Personal Data for as long as is necessary to provide you with our services for a reasonable period thereafter to enable us to meet our contractual and legal obligations (such as applicable laws and regulations concerning gambling and gaming, anti-money laundering, audit requirements and taxation) and to deal with complaints and claims.

We store customer contact, registration, transaction and payment information for up to 7 years after you cease being customers and verification and know your customer information for up to 5 years.

At the end of the retention period, your Personal Data will be securely deleted or anonymised, for example by aggregation with other data, so that it can be used in a non-identifiable way for statistical analysis and business planning.

How we protect your data

We implement appropriate technical and organisational measures to protect data that we process from unauthorised disclosure, use, alteration or destruction.

We have added SSL certificates to our Website to secure online transactions and to keep customer information private. This technology creates an encrypted link between the web server and web browser, therefore guaranteeing the safety of your information. SSL technology safely protects information from being captured by third parties.

We also rely on access control, regular monitoring, and backup of our systems to guarantee the safety, integrity, and availability of the Personal Data we hold. In addition, we also implement the appropriate organisational policies and procedures to ensure information safety is embedded in our activities.

We constantly improve our safety technologies to protect the system from unauthorized access and to make it impossible to use our database without permission.

In addition to the technical and organisational measures we have put in place, there are simple things you can do to in order to further protect your personal information, such as:

- Never share One Time Passcodes (OTPs).
- Never enter your details after clicking on a link in an email or text message.
- Always send confidential information by encrypted email to reduce risk of interception.
- If you're logged into any online service do not leave your computer unattended.
- Close down your internet browser once you've logged off.
- Never download software or let anyone log on to your computer or devices remotely, during or after a cold call.
- You can easily identify secure websites by looking at the address in the top of your browser which will begin <https://> rather than <http://>.

Your data protection rights

CopyBet would like to make sure you are fully aware of your rights. We will always ensure, no matter where you are located in the world, that we adhere to and fully respect your data protection rights.

You have the following rights if you are located in the EU:

Exercising your data protection rights
